Rector's Corner

As many parts of the nation begin to beat a retreat against the coronavirus, with the new Delta variant taking its toll, the great debate of personal rights versus community responsibility has intensified in toxicity and migrated into new battlegrounds, like over mask mandates for school children. Meanwhile, the virus, true to its nature, remains indifferent to these arguments.

From time to time, I hear a common lament: “How did this pandemic get so political?” The evasive yet perhaps diplomatic answer is, God only knows. Recently, I was asked by a friend to casually weigh in on the mask mandate debate in schools from a theological perspective, and, since I was driving home from New York at the time, I had plenty of time to ponder. Their state, like ours, has issued a mandate for all schools K-12. My friend sits on the board of a private Christian school considering defying their state’s order in the name of religious freedom. My friend supports masking while a number of fellow board members do not.

In putting together their case for the board’s discussion, my friend was leaning on Romans 13:1, which says, “Let every person be subject to the governing authorities for there is not authority except from God, and those authorities that exist have been instituted by God.” This verse from Paul’s letter is problematic on a good day, and every tyrant in the history of rule by divine right would give a resounding, “Amen!” Keeping the discussion in our present context, what would this passage mean for school

boards in Texas with the opposite problem: defying their governor in the interest of masking their students to keep them safe?

One of the issues with this verse is that biblical scholars are not entirely sure what Paul meant by it. The Rev. Dr. Cynthia Briggs Kittredge writes, “scholars have noted the tension, if not contradiction, between the perspective expressed here and Paul’s view that the form of the world is passing away (1 Cor. 7:31) and that the rulers of the world are ignorant of the purposes of God (1 Cor. 2:6-8; 15:51-58). The counsel against resistance seems at odds with the exhortation not to conform to the world (Rom. 12:1-2). Some critics have evaluated the counsel to be so out of place that they judge that the passage is not a part of the original letter.” What was Paul’s objective here? Was he expressing an eschatological resignation to governing authorities of this world, knowing that ultimately God’s justice will prevail? Was he simply trying to keep followers of Christ from crossing the brutal Roman authorities? Is there some very specific part of his context that we do not quite understand? The irony is, Paul’s explicit tone only prompts more questions.

I decided to recommend an alternative route to my friend. Instead of coming at it from a matter of obedience to civil authorities or not, a political approach, try coming at it from a matter of Christian ethics. Being a Christian school, whose mission is no doubt partly to teach following Christ and his commandment to love thy neighbor as thyself, something Paul references just a few verses later in Romans 13:9, how does defying a government mandate to wear a mask fulfill this mission? How does defiance on this particular issue support the Christian ethic of love and service of others? Romans 13:5 does say, “Therefore one must be subject, not only because of wrath but also because of conscience.” How does inviting the possibility of even one child getting sick, when masks have proven effective when worn properly, support a decision of the moral conscience, Christian or otherwise?

The short answer is it doesn't. It is a stance based on the fear of losing autonomy that is unfortunately stronger than the sense of duty to others. My friend, having far better scriptural recall than I do, found a passage that fit this pretty well in 1 Peter 2:15-17, which says, "For it is God's will that by doing right you should silence the ignorance of the foolish. As servants of God, live as free people, yet do not use your freedom as a pretext for evil. Honor everyone. Love the family of believers." What's more tragic is that the entire debate is driven by an adult fear. It's not the kids. As FHN's Infection Preventionist Margie Kochsmier observed in today's newspaper, most young people aren't all that bothered by wearing masks. As a parent, I can attest that aside from a general annoyance, they do not feel that inhibited by the prospect of wearing a mask. Our daughter does taekwondo in a mask, and for all I can tell, it makes her feel more like the ninja she hopes the class is going to make her.

All of this is to say, I know we are weary and I know returning to wearing masks and other safety protocols is a huge chip at our morale, especially given how close to "normal" we had gotten. But we still have a responsibility to each other. These protocols are what we can control right now, and they are the least we can do to protect ourselves, each other, and our little ones who look to us to model the way of Christ Jesus. We will get through this together. We will persevere through the setbacks and continue to celebrate the small victories for as long as it takes, because the power of God, working in us, can do infinitely more than we can ask or imagine, even in, especially in, difficult times.

Warden's Report

By the time you read this, Stephenson County may have dropped from current High transmission of virus back down to Substantial transmission. A few weeks ago, we went from a Moderate transmission rate to Substantial and back to masks in worship per the CDC recommendations. When will we go back to a Moderate transmission rate? Well, it depends on us and our neighbors to follow some simple guidelines: Wear masks inside places with more people than fit around your dining room table in a space no larger than your living room; get vaccinated; socially distance; wash your hands or use alcohol-based hand cleaners frequently, especially when not at home. Why wash your hands? Humans are notorious for rubbing without awareness our eyes and our noses, the latter a good place for viruses. Then folks push doors and handles and we do the same.

When is the pandemic done? It is much easier to find answers to when will it peak and slowly get better. The Institute for Health Metrics Evaluation estimates that Illinois is close to peaking in days. Hospitalization rates will peak about a week or two later. Deaths, about a week or two after that. Looking at Stephenson County's case rate, we have started to flatten out and maybe even drop a bit over the past several days. It won't just disappear fast, however. Not enough folks are vaccinated.

Like all good statistics, the guesses of peaks are based on probabilities of mask use rates, vaccination rates, and compliance with social distancing and hand washing. Those are things we can all do to help the peaks arrive when estimated or sooner.
