## Rector's Message

As we departed the first in-person Diocesan Convention since 2019, and the last in-person one for the foreseeable future, there were a lot of tears in the Prall vehicle. Lucy loves Convention, and she was going to miss her new friends. She also did not understand why I would not let her host a lemonade or hot cocoa stand to make up the Diocese's budgetary gap forcing us back to virtual convention. Charlie thought he had left a picture he made in the childcare room and did not understand why I was not hanging a U-turn in the middle of four lanes of I-88. And I had two crying children in the back seat. Tears all around.

Business, for the most part, ran relatively smoothly. The online voting system we had learned to use in past virtual conventions required a little learning curve on smart phones, but we got there. The following is my review of the resolutions and how everything shook out.

The first order of business was the Second Reading of a piece of legislation introduced last year for a proposed amendment to the Diocesan Constitution and Canons asking for gender neutral pronouns to be used in reference to Bishops and Clergy. Like last year, I do not think the amendment was adequately presented, leading to some to believe this was a sort of referendum on gender identity. It was not. The sponsors simply could have pointed out that currently in the Diocesan Constitution, when a bishop or clergy is referred to by pronoun it is he/him/his. Gender identity aside, that language does not reflect the reality of our diocese as we have many female clergy and we now have a female bishop. They/them/their in this circumstance would be perfectly grammatically correct for referring to a bishop or clergy of an unspecified gender. The amendment passed, so the handful of "No" votes either did not understand, or they do not believe women should serve in ordained ministry. The latter does still exist in our diocese.

For the resolutions, "Minimum Clergy Compensation" is an annual resolution, and it always passes. There was only one voice of dissent from a small parish with a small budget, and I fully understand their concern, but a fix would require the Church to completely rethink how it funds ministry (which might not be a bad idea). We also passed the resolution renewing our relationship with the companion dioceses of Renk in South Sudan and the Diocese of Southeast Mexico for a five-year period. It has been done on a year-to-year basis during our bishop transition. A resolution called "Migration with Dignity" asked that we align with other dioceses that have passed the same resolution voicing our support for the humane treatment of migrants and refugees within the parameters of federal law. It passed after clarification was given that it was not advocating for an open boarder policy. And finally, we passed a resolution asking the Diocese to provide greater awareness and support of Episcopal Asia Ministry, which serves a growing number of Asian Anglicans in the Diocese.

The Convention held the resolution, "Solidarity with the Palestinian Boycott, Divestment, and Sanctions Movement," for last, likely anticipating a long and impassioned debate. This proved fairly true as people rose in strong support both for and against the resolution. There was one call to table it in light of the current war. And there was one proposed replacement of the entire resolution, which snuck in on a loop whole where a proposed amendment, typically a sentence or two, can actually be an amendment to the entire resolution. That caused more consternation than any of the other proceedings, honestly.

I will spare you all the procedural back and forth that ensued, but long story short, it was asked that we vote by orders (lay and clergy), and it was asked that rather than just "Yes" or "No" a third option of "Abstention" be added to the ballot. Due to that third option, there were not enough "Yes" votes for the resolution to pass. So, for better or worse, depending on your viewpoint, the Diocese of Chicago has not officially joined in support of the BDS movement against Israel. Though I am curious about what the outcome would have been had the option for "Abstention" not been added, I think the process speaks to the complexity of the issue, and I also expect we will see another version of this resolution again in future conventions.

Overall, it was a good convention. The keynote speaker, the Rt. Rev. Jake Owensby, Bishop of Western Louisiana, was spectacular. It is always interesting to see Episcopal Church polity at work, and, like Lucy, I am sad we will not be meeting again in-person.

I hope you all have a blessed and prayerful Advent, as we wait with joyous anticipation for the incarnate God among us, our Emmanuel.
