### Rector's Corner

In the past couple of weeks I have received a few concerns about the Prayers of the People, particularly the length of the list of names being too long. Grace is certainly not the first church to encounter this issue, and it won't be the last. My seminary classmates and I even had a discussion about it just a few weeks ago. One friend has caused great anger for paring down his parish's prayer list. Another is navigating a local custom of including who the flowers are given in memory of as part of the Prayers of the People, which hovers a little close for comfort to the Roman Catholic practice of saying masses on behalf of specific people. And the others have their own little eccentricities to try to fix or make peace within their own contexts when it comes to what is "meet and right so to do" during the Prayers of the People.

While I have no immediate solution for the concerns here at Grace, I thought it might be worth exploring our intercessory work in the liturgy in this month's newsletter, starting with the fact that when it comes to the Prayers of the People, there is no "meet and right so to do" — that is, there are no hard and fast rules like we might expect for other parts of our service. In fact, it is a rare instance in the Prayer Book that starts out generally speaking, providing six basic concerns that should probably be prayed for at the very least. But the rubrics give a lot of latitude to how those intercessions are expressed. Forms I-VI are there to help us out, but we are certainly allowed to compose our own, and ones that may be more contextually relevant.

In his book *Ritual Excellence*, James Farwell, Professor of Theology and Liturgy at Virginia Theological Seminary, notes that these six forms were never required, but "were a good way to learn how to offer intercessions," especially in the church of the 1970s, which "was just learning to intercede in this way," as it transitioned from the 1928 Prayer Book to the 1979 book. Anymore, though, Farwell says,

The intercessions are the work of a priestly people, joining themselves to Christ in his continuous intercession for the world. First order of business: It is past time to retire the forms provided for the Prayers of the People in the 1979 prayer book. Intercessions should be delivered in such a way that they do not offer prayers while the congregation listens but invite the congregation – even *provoke* the congregation – to pray.

Ideally, Farwell recommends forming "a guild composed of those who have talents at composition and can compose prayers that resonate with the themes of the lections or the season." Now that would be an interesting prospect.

No doubt there is an inherent danger in our ritual prayer life of becoming too familiar and therefore disengaged as we seem to go through the motions. Ritual is a form of communication, which is really only as good as its ability to communicate. If it ceases to do so, then we must rethink it. Morning Prayer is a good example: what is a very meaningful part of our tradition to me is considered tedious to others, so we adapt to a degree.

When it comes to praying for people, though, it is not quite so simple. For every person who would prefer a shorter list of names, there is another person for whom hearing a name said aloud is very meaningful, and I will always err on being pastoral in this situation. It is a bit like some Grace traditions that are not particularly edifying to me, but we do them anyway because I know they mean something to someone.

That said, if you could help me by being good stewards of our prayer list, I would appreciate it. Remember I am often just

given a name and no circumstances, which is fine. I have no desire to pry into other people's business. But that also means I do not know if those circumstances have changed and our prayers are no longer necessary. So just be mindful of that.

I will continue my practice of using the notebook in the narthex to pray for people on the Sunday specified. If something more long-term is needed, just let me know. Meanwhile, there is an array of practices churches have adopted to address the indefinite prayer needs of their congregations that I will take into consideration, and hopefully we will find one that fits ours.
